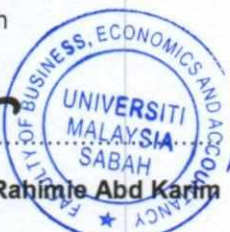

- f. This Letter of Intent serves only as a record of THE PARTIES' intentions and does not constitute or create any legally binding or enforceable obligations, expressed or implied.
