



MEMORANDUM OF UNDERSTANDING
BETWEEN
MALIKUSSALEH UNIVERSITY
AND
PERDANA UNIVERSITY



In accordance with the principle of mutual desire to promote international cooperation between Republic of Indonesia and Malaysia, Universitas Malikussaleh, Lhokseumawe, Indonesia (here in referred to as UNIMAL) and Perdana University, Kuala Lumpur, Malaysia joint in the following Agreement for education and scientific cooperation.

ARTICLE 1

Objective

The objective of this Memorandum of Understanding (MoU) is to promote ties between UNIMAL and Perdana University and to promote exchange between the two universities.

ARTICLE 2

Scope of Cooperation

Under this Memorandum of Understanding UNIMAL and Perdana University agree to:

- 1) Continue discussions as opportunities arise to ascertain the extent to which cooperative activities could be implemented in the future;
- 2) Collaborate on activities in key academic and research areas as needs and opportunities are identified.

In practice, the activities generated under this agreement may include:

- 1) To do research collaboration in areas of mutual interest.
- 2) Approaches to appropriate government and non-government bodies for funding;
- 3) Assessing possibilities to exchange internship undergraduate or postgraduate students; and
- 4) Assessing possibilities to organize joint international seminar or conferences.

ARTICLE 3

Plan of Action

Based on this MoU, UNIMAL and Perdana University agree to assist each other in drawing up and carrying out the concrete contents of various activity plans in different areas, which will be detailed out in separate collaborative agreements.

ARTICLE 4

Miscellaneous

This MoU does not presume or require any financial transaction between UNIMAL and Perdana University, but UNIMAL and Perdana University do not preclude either University/Institution from initiating in future discussions concerning a broadening or extension of this agreement that may result in other financial arrangements required.

Nothing contained in this agreement implies that an agency, partnership or joint venture between the universities has been set up, and it is understood that both UNIMAL and Perdana University will carry out activities under this MoU as independent institutions. Neither university/institution shall have any right or authority to create any obligation or responsibility in the name of, or on behalf of, the other.

This MoU will be effective for 4 (Four) years but may be terminated by either party upon written advance notification of not less than 6 (six) months.

This MoU is signed in identical copies in the English by the authorized representative of each university/institution, the two texts being equally valid.


